apply during the first 12 months following the opening of Your Account. Balance transfers completed within the first 60 days of opening Your Account, will qualify for 3.00% balance transfer fee and Introductory APR. Any existing balances on Landmark Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR: We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

Application of Penalty APR: Your APR may be increased to the disclosed Penalty APR if you are 60 days late in making a payment. If a minimum payment or any portion thereof is past due by more than 60 days, Your APR will increase to the Penalty APR as disclosed in the table under "Penalty APR and When it Applies." This Penalty APR will be effective following any notice and waiting period required by law. The Penalty APR will remain on Your Account until Your Account has been paid on time as disclosed in the "Penalty APR and When it Applies" section and with no other event of default.

Minimum Interest Charge: The minimum interest charge will be charged on any dollar amount.

Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Other Fees & Disclosures:

Late Payment Fee: \$25.00 or the amount of the required minimum payment, whichever is less, if You are one or more days late in making a payment.

Balance Transfer Fee (Finance Charge): 3.00% of the amount of each balance transfer during the first 60 days following the opening of Your Account. After that, You will be charged a fee of \$5.00 or 5.00% of the amount of each balance transfer, whichever is greater.

Cash Advance Fee (Finance Charge): \$5.00 or 3.00% of the amount of each cash advance, whichever is greater.

Returned Payment Fee: \$30.00 or the amount of the required minimum payment, whichever is less.

Returned Convenience Check Fee: \$30.00 or the amount of the returned convenience check, whichever is less.

Card Replacement Fee: \$6.00.

Pay-by-Phone Fee: \$10.00.

Statement Copy Fee: \$6.00.

Rush Card Fee: \$45.00.
